

ALDAR ACADEMIES PUPIL FREE UNIFORM TERMS AND CONDITIONS

PRIVACY

Participation in the BACK-TO-SCHOOL VOUCHER may require you to submit personal information about yourselves and any related pupil. The personal information will be collected, processed and used in accordance with the Aldar Academies Data Policy.
